PRIVACY POLICY

Accuwin, LLC ("Accuwin") has created this Privacy Policy in order to demonstrate its commitment to privacy. Accuwin recognizes that the visitors to its website(s) care how their information is used and shared. Accuwin wants its visitors to understand the types of information collected, how the information is used, and the safeguards in place to protect that information. This Privacy Policy is part of and subject to the Website Terms and Conditions posted on the Accuwin website ("Website") or other agreement between you and Accuwin and applies to the use of the Website or services which either link directly to this Privacy Policy, display this Privacy Policy or otherwise indicate that this Privacy Policy applies (the "Services"). This policy also includes Accuwin's information gathering and dissemination practices for the Website. **BY USING THE WEBSITE, WHETHER YOU ARE AN ACCUWIN CLIENT OR A VISITOR BROWSING THE WEBSITE, YOU AGREE TO BE BOUND BY THIS PRIVACY POLICY AND CONSENT TO THE COLLECTION, USE AND STORAGE OF YOUR INFORMATION.** Accuwin may update this Privacy Policy from time to time. The effective date noted below indicates the date that this Privacy Policy was last updated. Each Website visitor is responsible for checking this Privacy Policy periodically for changes.

WHAT INFORMATION IS COLLECTED AND STORED?

Accuwin may collect and store certain information automatically whenever you access this Website. The amount and type of information Accuwin collects depends upon your use of the Website. You may browse the Website without providing personal information. Accuwin passively collects information that is automatically sent by your web browser. This information typically includes your domain name. It may also contain additional information. The amount of information sent depends on the settings you have on your web. Each time you come to the Website, Accuwin may count, track and aggregate the visitor's activity for analysis of general traffic flows at the Website. This information is used to improve this Website and to provide you with an improved on-line experience.

USE OF COOKIES

Accuwin may use "cookies", which are files stored on your computer's hard drive by the browser. These cookies help Accuwin to identify visitors and to store preferences. The cookie does not

contain any personally identifiable information but does identify the specific installed program you use to browse the Website. Most browsers accept cookies automatically but allow a user to disable them. If cookies are disabled, you may not be able to take full advantage of a personalized experience on the Website.

IS INFORMATION SHARED WITH THIRD PARTIES?

Accuwin does not sell to others any personal information that may be provided to Accuwin through this Website, unless it is with consent as otherwise described in this Privacy Policy. Accuwin does not share personally identifiable information with third parties except for Accuwin's suppliers, contractors, business associates or other third parties with whom it has a written agreement providing for the same level of protection as provided by Accuwin under this Privacy Policy. If substantially all of Accuwin's assets are acquired by a third party, personal information may be included in the assets transferred as part of that sale.

Accuwin may engage third parties to perform services in connection with the operation of its business. Accuwin may provide personal information to these third parties. The purposes for which personal information is used include the following:

- . Contact information for potential clients or persons seeking information is collected in order to enable Accuwin to contact those persons to provide information about Accuwin's products and services. This information may be stored on Accuwin servers in the United States.
- . Contact information, such as your name, address, telephone number, or email address, submitted by existing clients, is used only to respond to inquiries.
- . Customer Content is may be provided to third parties in order for Accuwin to complete the services stated on the Website

Accuwin may release personal information if (i) it believes in good faith that it is required by law or legal process; (ii) it is required by a law enforcement agency that has provided a valid request; (iii) it is necessary to enforce our Website's terms of use; or (iv) it is required to protect our rights or such release is necessary to protect the rights, property or safety of Accuwin, its clients or others.
